On August 24, 2017 the Region One Education Service Center Board of Directors met to review and approve the recommendations of the Region One Purchasing Cooperative (ROPC), acting on behalf of its members, for award of Texas Essential Knowledge and Skills (TEKS) / State of Texas Assessments of Academic Readiness (STAAR) Aligned Assessment Item Bank, Proposal 16-AGENCY-000032. This Request for Proposal (RFP) allows Region One ESC, and its ROPC members, the opportunity to contract with qualified vendors for goods and/or services which include, but are not limited to, assessment items and delivery software capable of generating tests/worksheets, flash cards, and mirrored tests in Spanish and English at selected grade levels in each core content area, for use on an as-needed basis.

The term of this contract is effective September 1, 2017 through August 31, 2018 with three (3) additional one-year extension options if parties are in agreement.
