This proposal allows Region One Purchasing Cooperative (ROPC) members the ability to procure goods and/or services from a pre-qualified list of responsive and responsible Vendors, known as a company or firm whose purpose is to provide but not limited to, first aid rental and service programs; floor and restroom cleaning and supplies programs; drain treatment services; cold storage filter service; linen, mat, mop, towel and uniform rentals and service programs. Item descriptions, specifications and/or technical requirements and estimated quantities and pricing, and/or price lists and/or catalogs have been provided by each vendor enclosed. Region One ESC and its cooperative members are required to conduct a cost or price analysis for the procurement of goods and/or services not listed in the items tab, and within the scope of services offered with this bid solicitation. Cooperative members are responsible for the selection of goods and/or services available to meet their individual district needs.

On August 8, 2018 Region One Education Service Center Purchasing Department, acting on behalf of ROPC members, received three (3) responses to Facility Products, Services and Rentals RFP 19-AGENCY-000058.

On August 23, 2018 the Region One ESC Board of Directors met to review and approve the recommendation of the ROPC for Facility Products, Services and Rentals RFP 19-AGENCY-000058, effective September 1, 2018 – August 31, 2019 with three (3) one-year extension options if all parties are in agreement. Three (3) vendors were awarded after evaluation of cost analysis, cooperative member needs, and complete proposal submissions with an evaluation score of 70 or greater.

On August 22, 2019, the Region One ESC Board of Directors met to review and approve the recommendations of the ROPC for award of Facility Products, Services and Rentals RFP 19-AGENCY-000058, Extension 1 of 3, effective September 1, 2019 – August 31, 2020 with two (2) one-year extension options remaining, if all parties are in agreement.

On June 16, 2020, the Region One ESC Board of Directors met to review and approve the recommendations of the ROPC for award of Facility Products, Services and Rentals RFP 19-AGENCY-000058, Extension 2 of 3, effective September 1, 2020 – August 31, 2021 with one (1) one-year extension option remaining, if all parties are in agreement.

On June 22, 2021, the Region One ESC Board of Directors met to review and approve the recommendations of the ROPC for award of Facility Products, Services and Rentals RFP 19-AGENCY-000058, Extension 3 of 3, effective September 1, 2021 – August 31, 2022 with no additional extension options remaining.

The following vendors were awarded: **Model Laundry, LLC** – San Benito, TX; **Productos Ramsa, LLC** – Pharr, TX and **Unifirst Holdings, Inc.** – Harlingen, TX
