SUBJECT: **Region One Purchasing Cooperative Fire Suppression System and Vent Hood Installation, Training, Parts and Repairs RFP 19-AGENCY-000056, Extension 1 of 3**

This proposal allows Region One Purchasing Cooperative (ROPC) members the ability to procure goods and/or services from a pre-qualified list of responsive and responsible Vendors, known as a company or firm whose purpose is to provide but not limited to, fire suppression systems and vent hood systems, including but not limited to installation, training, parts and repairs that comply with the following, but not limited to, as applicable: National Fire Protection Association (NFPA), local Fire Marshal, and local Health Department. This request for Proposal excludes regular scheduled maintenance, inspections, and cleaning of these systems. Item descriptions, specifications and/or technical requirements and estimated quantities and pricing, and/or price lists and/or catalogs have been provided by each vendor enclosed. Region One ESC and its cooperative members are required to conduct a cost or price analysis for the procurement of goods and/or services not listed in the items tab, and within the scope of services offered with this bid solicitation. Cooperative members are responsible for the selection of goods and/or services available to meet their individual district needs.

On August 2, 2018 Region One Education Service Center Purchasing Department, acting on behalf of its ROPC members, received two (2) responses to Fire Suppression System and Vent Hood Installation, Training, Parts and Repairs RFP 19-AGENCY-000056.

On August 23, 2018 the Region One ESC Board of Directors met to review and approve the recommendation of the ROPC for Fire Suppression System and Vent Hood Installation, Training, Parts and Repairs RFP 19-AGENCY-000056, effective September 1, 2018 – August 31, 2019 with three (3) one-year extension options if all parties are in agreement. Two (2) vendors were awarded after evaluation of cost analysis, cooperative member needs, and complete proposal submission with a score of 70 or greater.

On August 22, 2019 the Region One ESC Board of Directors met to review and approve the recommendation of the ROPC for Fire Suppression System and Vent Hood Installation, Training, Parts and Repairs RFP 19-AGENCY-000056, Extension 1 of 3, effective September 1, 2019 - August 31, 2020 with two (2) one-year extension options remaining, if all parties are in agreement. The following vendors were awarded: **Industrial Fire and Safety, LLC** – Donna, TX; and **RMZ Kleaning Zolutions, LLC** – Mission, TX.
