This request for proposal (RFP) allows Region One Education Service Center, and its Region One Purchasing Cooperative (ROPC) members, the opportunity to procure integrated pest management services that includes, but is not limited to inspections of facilities, pest control plan, use of pesticides, rodent control, posting, record keeping, program evaluation and quality control programs. ROPC members are responsible for the selection of goods/services available to meet their needs. Item descriptions, specifications and/or technical requirements and estimated quantities and pricing, and/or price lists and/or catalogs have been provided by each vendor enclosed. ROPC members are required to conduct a cost or price analysis for the procurement of goods and/or services not listed in the items tab, and within the scope of services offered with this bid solicitation. Cooperative members are responsible for the selection of goods and/or services available to meet their individual district needs.

On August 24, 2017, the Region One Board of Directors met to review and approve the recommendations of the Region One Purchasing Cooperative (ROPC), acting on behalf of its members, for award of Integrated Pest Management Services Proposal 16-AGENCY-000030. Proposals were evaluated to select the best qualified vendors based on the established criteria. Two (2) vendors were recommended for award. The vendors were awarded for Integrated Pest Management Proposal 16-AGENCY-000030, effective September 1, 2017 through August 31, 2018 with the option to extend up to three (3) additional one-year periods if all parties are in agreement.

June 19, 2018, the Region One Board of Directors met to review and approve the recommendations of the Region One Purchasing Cooperative (ROPC), acting on behalf of its members, to exercise the first of three extension options for Integrated Pest Management Services RFP 16-AGENCY-000030, effective September 1, 2018 through August 31, 2019, with two (2) additional one-year extension options remaining. All vendors we offered and accepted.

On August 22, 2019 the Region One ESC Board of Directors met to review and approve the recommendation of the ROPC for Integrated Pest Management Services RFP 16-AGENCY-000030, Extension 2 of 3, effective September 1, 2019 - August 31, 2020 with one (1) one-year extension options remaining, if all parties are in agreement. The following vendors were awarded: ***Kill-A-Bug – McAllen, Texas*** and ***Little Joe's Insect and Pest Control Co. – Donna, Texas***
