Winners, depending on the number of competing teams, will advance to the State Championship Virtual Tournament March 4, 2022. The first-place team, in the State Competition, will represent Texas at the National Mock Trial Competition to be held in May.

Step Three: Please register with Region One ESC for the Mock Trial competition to be held on January 29, 2022. The deadline for registration for ESC Regional Mock Trial Competition is **December 17, 2021**. The fee is \$150.00, it's **non-refundable**, and is due January 14, 2022, after that date, a \$50.00 late fee will be assessed.
